Please Read the Following Conditions For Adopting Outdoor Cats

Outdoor adoptions are permitted from April 1-September 30 allowing animals sufficient time to acclimate to weather.

All outdoor homes **MUST** provide the following:

- All outdoor applicants must agree to a pre-adoption and post (if necessary) on site inspection by GCHS.
- Animals must be completely contained in a building for the first three weeks to acclimate to their new home.
- All outdoor homes must have 24/7 access to a warm shelter with continuous access to clean water, food, and bedding. Water and food should be provided at least twice daily.
- Adequate bedding such as hay, straw or a heated pet pad. (Please, no cloth bedding of any kind as it will hold moisture).
- Care must be available to injured or ailing cats. GCHS does its best to adopt out healthy animals however, there is no guarantee of the health of any animal.
- Adopted animals should be checked daily to insure that they are in good health and are safe.
- Shelter must be far enough from major thoroughfares and potentially hazardous equipment.
- Outdoor homes with aggressive dogs or other aggressive animals will not be considered..
- Outdoor adoption applicants must provide veterinary provider contact information for a reference check.
- All outdoor adoption approvals are at the discretion of the Executive Director.
